

Exclusions

ATP's exclusion list contains the companies which have been excluded from ATP's investment universe by our Committee for Sustainability due to violations of ATP's Policy for sustainability in Investments. The exclusion list applies to investments in both listed equities and corporate bonds, regardless of whether it is ATP's own employees or others who carry out the investments on ATP's behalf using ATP's funds. ATP may, through index derivatives, have financial exposure to companies that are on the exclusion list.
